

BEFORE YOU APPLY

- To commercially harvest timber other than fuel wood you require a timber resource licence and a cutting permit.
- Harvesting licence applications are subject to 30 day public and First Nation notification per Section 18(1) of the *Forest Resources Act*.
- The [Commercial Timber Harvest Allocation Procedure \(CTHAP\)](#) groups licensees into one of five categories based on capacity, good standing and commercial harvest history (if applicable) under the *Forest Resources Act*.
- New commercial applicants will qualify as either a Category 1 or Category 2 Licensee depending on their harvest equipment profile. Proof of ownership or rental/lease agreements of harvesting equipment may be required.
- If volume requirements for your business plan are greater than what is provided in the CTHAP you will need to discuss with a forester.
- To receive a harvesting licence you must obtain a YG Corporate Registry number through [Corporate Affairs](#).
- Authorizations may include a minimum harvest volume. Failure to harvest the volume may result in termination or amendment of the authorization.
- All applications are processed on a first-come, first-served basis.
