



FOREST RESOURCE PERMIT APPLICATION

PERSONAL USE PERMIT

BEFORE YOU APPLY

- Up to 25 m³ (11 cords) of fuel wood per year can be cut for personal use in approved areas. These permits are free and available online through the [Personal Fuel Wood Permit system](#) or you may apply at your local [Compliance, Monitoring and Inspections office](#).
- A forest resources permit (FRP) for non-commercial use is required for the harvest of green standing timber, fuel wood greater than 25 m³, sawlogs/building logs and non-timber forest resources (chaga, birch syrup, etc.).
- Stumpage fees may apply to FRPs which are issued outside of the personal use fuel wood permit system.
- First Nation notification of permit application may be required prior to permit issuance.
