- Criminal record check including vulnerable sector check obtained in the past 90 days. (Required for the applicant and all business partners or corporation directors. Attached or sent to Professional Licensing and Regulatory Affairs (PLRA) directly from RCMP.)
- Proof of a minimum of \$100,000 liability insurance.
- Proof of \$5000 surety bond.
- Photograph of uniform design. (Required if you have changed the design of your uniform. Security guard agency only.)
- Payment information form. (\$25 per licence class.)
