## **ELIGIBILITY FOR A GAMING LICENCE**

### **Background of gaming**

- In Canada, gaming is regulated under the Criminal Code of Canada.
- Section 207(1)(b) of the *Criminal Code* allows the Government of Yukon to issue a licence to a charitable or religious organization to conduct and manage a lottery scheme if the proceeds from the activity are used for a charitable or religious purpose or object.
- Charitable gaming in Yukon is regulated through the Lottery Licensing Act.
- Eligibility for lottery licences includes a review of common-law with respect to what is or is not charitable, as well as legislation, policies and guidelines that have been established.

#### **Basic eligibility**

- Determining basic eligibility can be complex. However, there are key components that the Registrar considers when assessing a group's eligibility for gaming licensing.
  - 1) Primary purpose In the law of charity, the court's primary concern is to determine whether the group's primary purpose is charitable. The organization may have more than one purpose, but the primary purpose must be charitable and the activities that the organization is engaged in must be sufficiently related to that purpose to be considered to be furthering them.
  - **2) Structure** Is it a broad-based volunteer membership and democratic? Do the offered programs benefit a significant segment of the community, not a member's self-interest? Is the organization registered as a society under Yukon's *Societies Act*?
  - **3) Program delivery** Has the organization been in existence for one year and actively delivering programs during that time? How do the group's programs or services benefit the community?
  - **4) Use of proceeds** How will the money be spent? Are the expenditures related to the organization's purpose and can they be seen to be furthering that purpose?

#### Questionnaire

• The questionnaire provides a framework that will provide information which is required to assist the Registrar in determining whether the organizations applying for a charitable gaming licence meets charitable requirements under the *Lottery Licensing Act*.
