

ASSESSMENT AND TAXATION ACT

Le Commissaire en conseil exécutif, conformément au paragraphe 56(3) de la *Loi sur l'évaluation et la taxation*, décrète ce qui suit :

1. Le Règlement prévoyant un impôt sur les améliorations locales afin de recouvrer les coûts concernant l'ouverture de chemins d'accès à Mendenhall paraissant en annexe est, par les présentes, établi.

2. Le présent décret entre en vigueur le 31 mars 1994.

**MENDENHALL ACCESS ROADS COST
RECOVERY LOCAL IMPROVEMENT
TAX REGULATION**

1. In these regulations, "local improvement" means the construction of access roads to serve the properties listed in Schedule 1.

2. The properties listed in Schedule 1 are declared to benefit from the local improvement.

3. To recover the cost of the local improvement there is levied on each property listed in Schedule 1 a local improvement tax consisting of the principal amount and the interest for that property in Schedule 1.

The local improvement tax

(a) shall be shown at a separate item on the tax notice for the property;

(b) is due and payable in the annual instalments shown on Schedule 1 at the same time as the general tax;

(c) is part of the total tax payable for the property; and

(d) may be paid in advance by paying the outstanding balance together with the interest accrued at the time of payment.

**RÈGLEMENT PRÉVOYANT UN IMPÔT
SUR LES AMÉLIORATIONS LOCALES
AFIN DE RECOUVRER LES CÔTS
CONCERNANT L'OUVERTURE DE
CHEMINS D'ACCÈS À MENDENHALL**

1. La définition suivante s'applique au présent règlement: « améliorations locales » la construction de chemins d'accès afin de desservir les biens-fonds énumérés à l'Annexe 1.

2. Les biens-fonds énumérés à l'Annexe 1 sont réputés profiter des améliorations locales.

3. Afin que le coût des améliorations locales soit recouvré, il est prélevé sur chaque bien-fonds apparaissant à l'Annexe 1 un impôt sur les améliorations locales constitué du montant en principal et de l'intérêt prévu à l'Annexe 1 pour ce bien-fonds.

L'impôt sur les améliorations locales

a) apparaît dans une rubrique sur l'avis d'imposition concernant le bien-fonds;

b) est exigible en versements annuels prévus à l'Annexe 1, à la même date que l'impôt général;

c) fait partie de l'impôt total exigible sur un bien-fonds;

d) peut être payé avant terme en payant le solde du montant en capital et les intérêts accumulés jusqu'à la date du paiement.
